- 2. <u>New Business</u>
 - a) 2002-03 Harvest Study Budgets
 - i. Harvest Study Budget
 - Received letter from Implementation Committee indicating that no extra funds are available for the Harvest Study; SRRB to work within the funding allocation given (\$103, 616)
 - Require \$87,000 to properly run the Harvest Study; to take funds from the Core Operating Budget (\$30,000) and the Wildlife Studies Fund (\$57,000)
 - Leaves \$156,572 available for research funding
