Jan 16,1996

After the opening prayer there was an introduction of all present. At that point John Tetso, Grand Chief Deline, welcomed the Board to it's first meeting and stressed the importance of the member's role on the Board. "It's and important position and the members should listen and make strong decisions." He wished the Board well and remained to view the mornings proceedings.

Sahtu secretariat Incorporated representative, Larry Tourangeau, handled the proceedings and discussed how the Board should operate for the people they represent in the Sahtu. He gave a presentation that outlined some of the history of the claim and the make-up of the region with the 3 districts. He noted that other Boards have already been working on their own for some time and we could use some of their experience, as well as, some of the work they have already done.

All Members and Alternate's were sworn in and the meeting was turned over to Winter Lennie to proceed with appointment of Interim Chairperson. Winter Lennie was nominated as Interim Chairperson. The members then appointed a Personnel Committee to look after the recruitment of a full time Chairperson and an Executive Director. These committee members are George Barnaby, Russ Hall, Winter Lennie, Jimmy Tucho and Gerry LePrieur. The Finance Committees made up of members George Barnaby, Paul Latour, Jimmy Tucho and Winter Lennie. At present signing authority will be held by Winter Lennie and Gerry LePrieur, who reside in Norman Wells.

Jan 17,1996

The Sahtu Regional Biologist, Alasdair Veitch, gave a presentation covering the happenings and study activities being carried out in the Sahtu. A brief summary of the project and results were presented with a slide back up to reinforce the need for more research. Alasdair also made a presentation on behalf of the Bluenose Caribou Management Committee. He noted their activities up to this point and solicited a representative from the board to be part of the management committee. The Board will consult with the Renewable Resource Councils from Fort Good Hope, Deline, Coleville and Norman Wells for someone to represent the Board on this committee.

Fisheries, Oceans and Coast Guard, District Manager, Ron Allan, and Director General, Ray Pierce were in town meeting with the Department of Transportation and asked to make a presentation to the Board. Their main focus was contact with the Board and to enforce the idea that the Board was an important management tool and that all government members worked for the departments, but, worked on behalf of the people of the Sahtu.
