## 9. Species at Risk Information Session Report

- Species at Risk Information Session Report & NWT Species at Risk Chart
- All of Canada's species (mammals, birds, amphibians, reptiles, fish, mollusks, butterflies/moths, plants, lichens & mosses) are assessed
- National Aboriginal Council on Species at Risk has been established to advise and make recommendations to Federal & Provincial/Territorial Ministers
- Species at Risk prohibitions (fines and jail time) are only for threatened or endangered species

## 10. Agency Updates

#### a) RWED - Alasdair Veitch

- Mammals PowerPoint Presentation tabled
- Calving grounds of the Bluenose-east caribou herd are currently NOT
- Harvest of barren-ground caribou are within sustainable limits (about 4000 caribou harvested out of 200,000)
- In the Sahtu, no drugs are used when collaring caribou (net gunning only); blood samples are taken from caribou during collaring
- To date, no West Nile Virus found in the NWT

## **Concerns/Issues**

1. Gun Licenses/Registry – Richard Kochon

Harvesters have difficult time filling out their forms; therefore, affecting their harvesting activities. Sometimes it takes 1-2 years before they receive their license. Some of them send their forms out but are sent back asking for the right size pictures to be included. They get the run around to receive their license. RRCs want to know if the SRRB can help write a support/recommendation letter. People are concerned that their right to hunt is being taken away.

SRRB response: The land claim gives its people exclusive rights to hunt, fish, trap and gather in the Sahtu Settlement Region. The Board can send names of people available to come into the community to help fill out applications.

2. Education and Training – Andrew John Kenny

We should work together so that we are strong. Everyone has to know whatever is happening with our land claim so that we make the right choices for the future. If we work together as a region with our young people to get their education and training in the wildlife field it would benefit our communities. Right now it is hard for our young people because of lifestyles changes. They need more education and training to get ahead. Is there education and training in environment/wildlife field in place?

SRRB response: The SRRB and RWED have summer student positions. Community members are encouraged to participate in research projects in and around their area. Scholarships are made available to students pursuing education in renewable resource-related fields. There are a lot of opportunities for training and education in these areas but the young people have to be interested as well as have community and parental support.

3. Training and Counseling in our communities – Alphonsine McNeely Additional comments #2

We should try to heal ourselves and then help the young people in the communities. The reason they do not want to do anything is because they are not healed inside. We should get the youth and women involved in things happing today. Women have lots of knowledge and are powerful when it comes down to dealing with their children. We should train counselors to help heal our children within our communities.

4. New traps – Boniface Ayha

I am having trouble using the new traps (conibears). You always have to make sure you have someone with you when you go out on land because it is dangerous when you don't know how to use it. What can SRRB do to help us in this area?

SRRB response: Alasdair Veitch – RWED Officers and/or Communications Officer can help educate trappers about safe use of these traps..

5. Funding allocations/Implementation funding distributions – Wilfred Lennie Sr. At our last SRRB meeting, the RRCs were told to leave when it came to deciding on allocating funds to research projects. RRCs should be involved in when the SRRB makes decisions on funding allocations.

SRRB response: We understand this was a hot issue at the last meeting. Research applications are sent out to RRCs for review and input before the SRRB meetings. RRCs are given time to provide input during the meeting. The land claim gives only Board Members voting power (equal voting by Dene and government representatives). This is the only way for the SRRB to remain independent and fair.

The same amount of monies is given to each of the five communities even though some communities have more members.

SRRB response: The Sahtu Implementation Committee decided how ALL monies would be distributed, including how the RRCs monies would be divided for the first 10-year period. This is an issue that SSI would have to address.

6. Harvest Study – Richard Kochon
People in Colville Lake are not comfortable reporting their hunts because they still
think they are going to be prosecuted. They think we will be giving out their names
of their hunts when officers ask for it.

Harvest Study Coordinator response: The harvest Study protects the identity of the harvesters by using numbers; only I know who is who. All records are locked up at the office. Any information collected will never be used to prosecute a harvester; rather, it is to protect your traditional harvesting. I know we have not visited the communities for a while but once the data is completed in the database, we will be touring the communities to update and refresh on the Harvest Study.

7. Harvest Study – Wilfred Lennie Sr. Harvest study records and RWED records should be combined. We want to be able to compare harvester's numbers of other harvesters and in our area.

Harvest Study Coordinator response: This is a study of the Sahtu beneficiaries and harvesters that reside in the five Sahtu communities.

SRRB response: SRRB and RWED will provide harvest data summary of all subsistence harvest and non-residents harvest.

#### 13. RWED Update cont. – Richard Popko

- Birds PowerPoint Presentation tabled
- Harvesters are the 'eyes and ears' on the land

- Currently, working to get a baseline of wildlife health in the Sahtu, including birds; harvesters are encouraged to bring abnormal samples into RWED, which are then sent to a veterinary school in Saskatoon
- 99% of waterfowl banded at Willow Lake are shot down south in the United States; the banding project is a long-term project that can show what is happening across the continent, e.g., marshes destroyed in Louisiana can affect the number of birds found at Willow Lake
- The use of steel shot has shown a significant decrease in lead poisoning
- Biologists and veterinarians are studying parasites (worms) and diseases to better understand how they affect wildlife; climate changes are good for parasites (warmer temperatures lead to more parasites)

**ACTION (ED):** To send out copies of 'A Field Guide to Common Diseases & Parasites in the NWT and Nunavut' for both wildlife and fish

## 14. 2000-2001 Harvest Study Data Report & Funding Proposal

- 2000-2001 Data Report and 2003/2004 & 2004/2005 Funding Proposal tabled
- Due to an error made while preparing the participation rate for the 1998-1999 Data Report, a revised Response Rate has been calculated and made available to insert into the report
- Data collected from harvesters will be used: 1) to determine the Sahtu **Basic**Needs Level of Dene and Metis so that their harvesting traditions on the Land
  can be protected, 2) to ensure effective management of fish and wildlife in the
  Sahtu, 3) to assess the potential impact of new or existing developments (e.g.
  oil, mining, tourism) on harvesting, and 4) can be used to determine damage
  or loss to harvesting caused by development or disaster (compensation)
- Demonstration given to show how the Basic Needs Level will be calculated
- Funding proposal submitted to DIAND to continue the Sahtu Settlement Harvest Study until 2005

**ACTION (ED & RWED):** To summarize and combine subsistence, resident & non-resident harvests into one report for Sahtu organizations

## 15. Projected Implementation Needs

- Deadline for submission: September 25, 2003
- Additions to cover letter & budget should include:
  - Environmental Assessment Biologist (\$65 k)— this position would be funded by the SRRB but would be stationed in Norman Wells with RWED; added to deal with increasing development in the Sahtu (oil/gas, pipeline, hydro, etc)
  - o Salaries should show an incremental raise of 3% per year
  - Professional Development & Training should be 5% of total Salaries instead of 2%
  - o Board Training (\$8 k)
  - Increased travel costs because of isolation of region (no roads & dependence on air travel) and 9-11 tragedy
  - Ensure that monies are available for Communication Officer's programs

 Board focus on conservation education and how to cope with impending development

#### 16. RWED update cont. – Alasdair Veitch

- Moose PowerPoint Presentation tabled
- SRRB funded Fort Good Hope Moose Survey (\$20 k) based on Yukon example, the March 2004 survey will be fixed-wing only along with a community-based monitoring system
  - Pilot project in NWT; community-based monitoring system will be designed and implemented with community RRC
  - o 15 to 20 active harvesters will make moose observations (location, group size, age & sex) from August to October; observations are kept confidential, summary made public, and RRC holds original data
- Training to be coordinated by RRC, Communication Officer and RWED
- RWED not requesting funds from industry because they want to ensure that research remains independent from outside influences
- Suggestion that Board have an annual day where researchers and RRCs can give presentations; does not interfere with regular Board business; can not be interrupted or preempted (a lot of work goes into producing presentations)

**ACTION (SRRB):** To host an annual Research/Information Day (prior to board meeting), where researchers and RRCs can present and discuss research projects in the Sahtu
