 - Community conducted own caribou survey and conclude that more than 18,000 Bluenose-West Caribou; wolves play a huge part in caribou management
 - Concern about helicopters/aircraft and noise
- Norman Wells RRC – John McDonald, Member
 - Concern about harvesting and exporting trees from private lands; land claim wording “affected RRC” unclear

- Encourage all RRCs to meet together more regularly besides SRRB meetings
- Deline RRC – Alfred Taniton, Member
 - Many barren-ground caribou did not migrate to Kugluktuk; were these animals counted during the photo surveys? Has the impact of fire on barren-ground caribou been examined?
 - Suggested better involvement of community and regional organizations for better cooperation and less controversy over survey results
- Fort Good Hope RRC – Roger Boniface, President
 - Respect what Colville Lake and Deline are saying about the caribou b/c they live with them but must also listen to scientific information; therefore, it is difficult to make recommendations
 - Concerns about wolves and development; increasing numbers of beavers and no trappers
 - Suggested to put monies towards on-the-land surveys instead of aerial surveys (less costly)
- Tulita RRC – Boniface Ayah, Member
 - Concern about the lack of respect for animals; lots of wastage seen at dumps

- Scholarship program to award \$1000/ year to three students entering into wildlife management related schooling; possibility to do in conjunction with SRRB’s scholarship program
- Concerned about ATV, jet boat & helicopter access
- Request to open grizzly bear season (two bears/outfit/year)
