 - Monitoring contracts with industry (oil/gas/mining); monies used to aid harvesters (gas & equipment); hosting a Monitor Training Course – October 2007 in Tulita
 - Concern about harvest by non-beneficiaries; revise the Harvest Study to keep track of harvest in the Sahtu
 - o Limited funds available; unable to attend many workshops/conferences

 - Contracts with industry and researchers for monitors; however, shortage of people available
 - Provide support for on-the-land programs (gas & equipment); limited funding available; require non-beneficiaries to request access to harvest
 - Often difficult to get information from Land Corp that is needed by the RRC to make decisions
- Norman Wells RRC Jackie McDonald, Member
 - o Contracts with industry for monitors
 - Provide travel assistance for spring/fall hunts; cabin packages

- Northern Lights Uranium 200 man camp at Mile 222 no permits obtained; camp shut down after inspection by INAC and Tulita District Land Corp
- Behdzi Ahda' RRC no delegates in attendance

12. Agency Update – Sahtu Land & Water Board (SLWB), George Govier

- Presentation, entitled "Land Use Permits & Water Licences Presentation to the Sahtu Renewable Resources Board, September 11-13, 2007", tabled
- Change in emphasis from oil/gas to minerals
- SLWB does not collect security deposits (only recommend amount), rather INAC; Imperial Oil has \$30 million deposit held by National Energy Board (NEB)
- Terms & conditions have been upgraded over time, including the use of environmental monitors; no way to enforce that monitors be hired through RRCs
- To date, no outfitters require land use permit or water licence; Association of Mackenzie Mountain Outfitters has requested to be added to the referral agency list

16. CIBC Asset Management Update – Deborah Lewis

- PowerPoint Presentation, entitled "CIBC Asset Management Sahtu Renewable Resources Board, September 11, 2007", tabled
- Past managing style value added; portfolio underperformed due in part to Bonds (interest rates increasing: bonds decreasing); change to index class mandate which will see outperformance over time
- CIBC doesn't invest in third party commercial paper due to underlying market problems; Govt of Canda bonds are good; volatility in fixed income increasing; high profile bonds in portfolio; bonds provide stability over time (steady returns); however, returns will not be as high (max 4-5%) as they have been in the past (up to 11%)
- Canadian equities less diversified; underweight in both Industrials and Info Tech which impacted portfolio; CIBC doesn't get into all up market stocks as this protects clients much better during down markets
- US Equities broader range of returns; equities have risk involved but get 7-10% returns
- Income trusts in 2011, Govt of Canada will begin to tax income trusts; some income trusts will cease to exist over time; this will be a big impact to portfolio; suggest leave as is b/c market is currently reacting to short term issue
