Discussion

- Timelines it is not possible to make a decision for the current harvest season because of time required for the hearing process
- The Minister of ENR is obligated to establish pekwé harvest allocations because of the way the act is written
- Challenge of accommodating community opposition to the tag system while recognizing the need for cross-regional allocations and some way of monitoring harvest
- Benefits of the community-driven approach to harvest management and monitoring
- Update on Déline zekwé conservation planning process
- Concept of "declining trend," and causes of decline
- Perspectives from other regions, including Wek'èezhìi Renewable Resources Board, Nunavut, and cross-regional ACCWM forum.
- Harvest monitoring in other regions
