2. Sahtú Land Use Plan Amendment Proposal - Nááts', hch'o Area

- Government of the NWT letter supporting designation of zones excluded from originally proposed Nááts'įhch'o National Park Reserve boundaries as General Use Areas to encourage development; current designation is Proposed Conservation Initiative zone.

- Not appropriate for the SRRB to provide input into the land use planning and NWMB proceedings related to Bluenose East pekwé and habitat, since we're in the midst of our own hearing.
- The SRRB can however send a letter signalling that the Board has heard from all Parties on the importance of protecting Bluenose East ?ekwé calving grounds, and will be exercising our discretion to review the NWMB public registry for relevant information.

The Sahtú Secretariat, Inc. has drafted a letter for joint submission with the SRRB to ENR requesting review of Special Harvesting Areas as defined under the land claim agreement, and dialogue about approaches to implementation. This would require community consultation.

8. Budget and Workplan for 2016-2017

Deborah Simmons

Negotiation of the 10-year implementation budget has been delayed again, so this year it is recommended that the Board submit a budget that more closely reflects actual costs. The annual increment is calculated according to Final Domestic Demand Implicit Price Index (FDDIPI) at a little under 1.6%, which in relation to increased staffing, travel, office rent and other costs represents another effective decrease in our budget. The supplemental budget request would notably include cost for another professional staff person plus participation costs for ?ehdzo Got'įnę (\$100,000).
