2. Bluenose East ?ekwé Hearing

Presentation by Lorraine Land and Deborah Simmons

- Briefing on option to extend timeline for final report to allow for legal responsibility to provide bereavement leave for Deborah Simmons; the Wek'èezhìi Renewable Resources Board pushed back their final report by 1.5 weeks, and has split their report into two phases – first related to determination on Total Allowable Harvest, and the second for all other issues.
- Overview of final submissions by Parties and proponents (ENR and Déline)
- NWMB Hearing: submission by Kugluktuk Hunters and Trappers Organisation, referring to the Dél_lnę zekwé conservation plan as a community-driven approach that they wish to adopt
- Communications: there is a need need for communications assistance related to issuance of SRRB
 hearing final report; Joanne Stassen who worked with us prior to and during the Déline hearing is no
 longer available (returning to work at CBC North Radio); recommendation to hire someone else who
 is independent and knowledgeable about the issues

- How SRRB and WRRB decisions can be reconciled if there are differences, or whether this is a concern
- Approach for a submission to the NWMB, given that the deadline for submissions is past, and the SRRB is constrained in commenting since we are still in the midst of our own hearing process
- The need for all Board members to participate in reviewing final report to ensure strong consensus, noting that we have one less Board member following Lesley Allen's resignation (as alternate for Lesley, Pat Bobinski could assist the Board in developing consensus, but would not be able to vote since he was not a participant in the earlier phases of the hearing proceeding)
- The final report would be relatively short and pithy, but including quotes from participants; quotes can be used since the proceedings are on the public record
- Though it is not possible to do a full retranslation of Dene language contributions within our budget and timeline, we can do checks on interpretation of key quotes for Dene language speakers

3. Follow-up on Lesley's resignation

Presentation by Deborah Simmons

Review of Lesley Allen's May 2 letter of resignation, commenting that she finds the SRRB's "processes and practices ineffective and inefficient, and there is little interest in making changes." Is there a need for any follow-up, or discussion of lessons learned? This is a signal to staff about the importance of continuing to try to do better. The honoraria are relatively small and won't increase for some time; nevertheless we need find ways to make this Board a place where people want to participate because it is rewarding and meaningful, not just a drain on energy.

Discussion topics

- The letter will be distributed to all Board members
- On the bright side, INAC Implementation Branch has informed us that they have flagged our supplemental submission as a priority, so we seem to be in good standing with them
- Lesley took on a major burden of reading, participating in the Executive Committee, and participating in SRRB activities
- The hearing was very stressful and may have taken a toll
- The staff sent a card and a beaded bag as thanks on behalf of the SRRB

4. Wildlife Studies Fund

Presentation by Deborah Simmons

Overview of proposed budget: Unspent from 2015-2016 was \$239,915; Wildlife Studies Fund investment revenue from 2015 was less than usual at only \$81,073, for a total possible budget of \$320,988. Priority over the coming year to work with CIBC Global investment managers to ensure that investment revenue is maximized. Recommend continuing funding for ongoing projects, and adding three items that have not previously been funded, as follows:

- Sahtú library project
- Sahtú Environmental Research and Monitoring Forum researcher travel
- Tulít'a Mountain Caribou book completion

Discussion topics

- Noted that the budget currently is over by \$10,000; recommend revising the budget to reduce the Community Mapping Initiative budget to achieve the balance
- The Community Mapping Initiative budget has not been used in part because we have been successful in leveraging the SRRB contribution for project funding; reminder that any expenditures from this budget must be based on project proposals reviewed and approved by the Board
- Any potential duplication of projects with ENR? none identified
- ENR projects being proposed to date include grizzly bear population genetics, Northern Mountain caribou management issues, collaboration with Tulít'a to develop muskox research proposal; Heather Sayine-Crawford has been very helpful in keeping us informed
