Geology and Climate Change Research Presentation

Presentation by Dr Rhodri Jerrett, Dr Bart Van Dongen, and Emily Dearing Crampton-Flood at the University of Manchester; Professor Gregory Price and Dr Sabine Lengger from the University of Plymouth

- The project focuses on the turbulent and large climatic shift that is associated with one of the 'big five' mass extinctions, where the land-based dinosaurs and other forms of life became extinct. The research explores the tempo and magnitude of temperature change during the Cretaceous-Paleogene boundary.
- This major mass extinction saw a dramatic decrease in diversity and abundance of terrestrial flora and fauna including the dinosaurs. However, estimates of terrestrial temperatures during this mass extinction are poorly known, thus limiting our understanding of these purported environmentally-driven changes in biodiversity.
- During the late Cretaceous to Eocene (100-34 million years ago), global mean annual temperatures were up to 8C warmer than today. This is referred to as the 'Greenhouse World'. Fossil data suggest that temperature-sensitive flora and fauna, such as reptilians and frost

intolerant trees, were living in the Arctic-circle during this period. This indicates a climate system that operated in a fundamentally different way to the modern 'Icehouse World' that we live in.

- However, General Circulation Models of climate do not reproduce this warmth which has important implications for the prediction of future climates and might suggest that we may currently be underestimating future climate change in such polar regions.
- The National Environment Research Council, United Kingdom (NERC) funded 'Equable Earth' project seeks to provide evidence to answer a critical question about past greenhouse climates: Was the difference between equatorial and polar temperatures was substantially reduced?
- Dust in layer in coal with iridium which is very high in meteorites. We know sites are the same same age because iridium landed at same time, looking at change from before and after meteorite impact.
- Attempting to look at sites from New Mexico to Tulita look at exposed coal representing squashed peat with temperature molecules.
- Will produce public dissemination and report to the board results will come out in the next two to three years.

Joanne Krutko joined the meeting.

- The Nío Nę P'ęné plan and urgency of decisions for mountain caribou conservation.
- Urgency of decision-making with respect to barren-ground caribou harvest regulation and Dene ts'll.
- Importance of giving communities time to prepare what they want to say.
- Need to avoid creating a process that is confusing for people and makes them angry.
- The challenge is that the final report on all the Public Listening Sessions will be years in the future. This could mean a delay in plan approvals. The Board can make interim decisions after each Public Listening Session, and can also approve portions of plans, encouraging iterative plan development.

- Option of holding workshops instead of hearings; the tradeoffs are the decisions are less weighty from the standpoint of the Minister of ENR, and may be more difficult to fund workshops.
- Chronic issue of securing funding for Community Conservation Planning (CCP) processes.
- Proposed approach for Public Listening Session 1, to take place third week of January 2020 per Colville's suggestion: focus on harvest regulation with a spotlight on Colville plan; regional CCP workshops to help all communities prepare as well as funding for local preparation activities, and more substantial funding to help Colville prepare and host. Funding is also budgeted for participation of organisations from neighbouring regions, as well as technical advisors to the SRRB.
- Backup plan if Colville declines the invitation to partner on 2020 Public Listening Session.

Next Steps

- Revise workplan
- Research on key things like how does consensus work in our process
- Board review of revised work plan
- Formal invitation to CL to host and collaborate on a workshop
- Presentation to Sahtu leadership about the workplan
- There are different voices in the meeting. Staff and legal council will work to reconcile the voices grounded in the discussion we just had
- Agreed that this process needs to be set up for success by having communities, and youth, take ownership of the process
