- Some of Tulít'a's traditional hunting territory is withing Colville Lake's zone.
- Kristen Jensen will work with Tulít'a ?ehdzo Got'ınę to facilitate a discussion between the two communities.
- Tulít'a has invited Colville Lake to present their plan to community members.
