2. SRRB Partnership for Woodland Caribou TEK Project

- o SRRB has been asked to partner with GRRB and RWED on a Woodland Caribou TEK project; being asked to provide in-kind support only (e.g. participate in workshops, provide input into TEK questionnaire, provide any expertise required)
- o GRRB to 'quarterback' the project; will try to gather most funding through the habitat stewardship program

3. Hydroelectric Development Plan - SRRB Involvement?

- o As Celina & Ruby were unable to participate in the board conference call on 21 Sept. 2001, they wished to know the board's position on hydro development
- Jody explained that the board was in favor of a pro-active approach;
 involvement with all affected organizations (in both settled & non-settled regions) to devise a unified response to hydro development

4. Permitting Wildlife Research

- SRRB to urge RWED to take steps to plan a wildlife research permit workshop;
 to include SRRB, RRCs & district land corporations
- o Discuss at meeting with Doug Stewart and follow-up with letter

5. Executive Director Trainee Job Description

- o John Stevenson from RT & Associates completed a draft version of a job description for an executive director trainee
- o Committee gave okay for Mr. Stevenson to proceed with developing a training plan

6. Meeting Attendance Policy

- Concerns raised about poor attendance by any Sahtu organization's representatives at SRRB meeting, specifically those individuals who the board has paid for
- > To recommend to the board that any individual brought to board meetings to represent a Sahtu organization, i.e., travel costs paid for by the SRRB, and do not attend:
 - The organization will be notified by letter that the individual did not attend the meeting
 - The organization will be invoiced for all costs covered by the SRRB
 - If a representative fails to attend two (2) meetings, the organization will be notified that the individual will no longer be allowed to attend on their behalf

7. Policy & Procedure Manual

o Judith Wright-Bird has expressed the wish to complete the manual; has been given a deadline of Friday, October 19, 2001 to complete

8. Meeting with Doug Stewart

- o To be held at EMLC at 9:30 a.m. on October 11, 2001
- o To discuss recommendations for regulation changes and reallocation of wildlife resource revenues

9. Staff

- Jody indicated that Ben had mentioned that he may leave his position as of April 1, 2002
- Committee asked that if he does intend to leave, to provide a letter of resignation dated March 31, 2002 to allow the board to begin a search for a new biologist

10. Index Netting Project - Fort Good Hope

- o Fort Good Hope RRC did not complete the work for the index netting project; letter written to RRC, Yamoga Land Corporation & Metis Land Corporation expressing the board's disappointment that the project was not completed
- o To write letter to Sam Stephenson DFO to reimburse the board (\$2600) so the board may re-allocate the funds to future projects
