#### Moose and Caribou Health monitoring

- Deb and Susan agreed to partner in developing a webpage for the moose and caribou health monitoring project, including links to reports, the video, and the anatomy atlas, as well as biographies and photos of project team members – so that people will have easy access to project materials.
- Heather Regarding Déline caribou harvest this year, have developed a smaller kit, goal is at least 100 samples this year.
- Deb Overview of meetings in Inuvik this week between SRRB, GRRB, and WMAC. Looking for ways to support community involvement in caribou conservation.

#### **Re/mediating Indigenous Environmental Justice: Resource Extraction, Divergent Risk Perception, and Economic Equality in the North** *Alana Fletcher, Queen's University*

Alana sent an email with her regrets that she is unable to join the meeting, along with the following introduction to her research:

- I am an adjunct professor of English at Queen's University in Kingston, Ontario, where I completed my PhD in August 2015. My research expertise is in contemporary Canadian and Indigenous literatures, environmentalism, and adaptation theory.
- For my dissertation, I examined how adaptations of Deline community oral histories (into films, essays, plays, etc) strengthened the claims people were making about uranium contamination. I found out about the history of Port Radium from a film, in fact -- Peter Blow's Village of Widows. I visited Deline in summer 2014 to speak to people about whether they were familiar with the works I was studying and what they thought of them, and to see what progress had been made on the 2005 Canada-Déline Uranium Table (CDUT) recommendations.
- At the end of this trip, I became interested in the collection of materials held at the Déline First Nation -- materials relating not only to the CDUT process but to land claims, traditional languages, and other topics. When I went back to visit Deline in summer 2015 I spent some time cataloging the materials there and trying to discover what work had been done with them so far. In terms of Deline projects, it is this attempt to complete a usable community archive that could be part of the DKC that I am most interested in now. I am hoping that I might be able to return to Deline to work on this on a contract basis with some support from the SRRB's Sahtu Library Project.
- Both times I visited Deline I stayed with Bernice and Morris Neyelle, with whom I became pretty close. Another project I am working on concerning Deline is Morris's book of his father's life and stories. I am editing the book and making applications for grants to support our work on it. One

thing I will need help with on this project is the orthography and English translation of some Slavey words, especially those relating to places, rivers, and land formations.

• I think that's about all for now. I would be very happy to be contacted by anyone who has input on either of these ongoing projects or anyone who sees fruitful collaboration between my work and their own.

- James Some licenses are for multiple years, others for short term, and some topics get studied more than others.
- James How effective are the studies? Joe Any examples to clarify this? James Fort Good Hope has put a lot of effort into the Ramparts Protected Area Strategy, and now some guy got a license to study how effective the strategy is. Why fund somebody like this, trying to undermine the community work? (Note: Joe believes that this is the study in question: <a href="http://data.nwtresearch.com/Scientific/15559">http://data.nwtresearch.com/Scientific/15559</a>)
- James Do students doing their thesis need a license? Joe Yes, they need a license.
- Walter comments on this process from the Déline perspective. Walter (with Ed's help) plays a role in screening research license applications for community leadership organisations.

- Discussion of possibilities for customizing process for Sahtú region. The structure of the land claim gave rise to the current referral system.
- Deb suggests having a person from each community (eg. the Sahtú ERM Forum representatives) in charge of reviewing licenses, rather than every organization receiving a request. Goal is to get written consensus from all organizations on current referral list.
- Laurel Suggests including SYN representative in license review.
- Jonathon confirmed that it is possible to establish a new referral process for the Sahtú. For example, a revision to the Terms of Reference for the Forum giving community representatives a higher level of responsibility in the licensing process could work, if approved by Sahtú leadership organisations.
