# Background

The SRRB wishes to thank all the Parties and the public for their contributions to the Colville 2020 Public Listening Session. The Board is now preparing for our decision meeting on February 11-13. As a result, the public record for this proceeding will close on February 10, 2020. The Board is only able to consider evidence that is included in the record. This update provides information related to evidence following from the January Public Listening Session.

# **Draft Transcripts**

<u>Draft transcripts</u> of the Colville 2020 Public Listening Session have been provided by <u>Digi-Tran</u> and posted on the <u>Public Registry</u>. The drafts are provided for review by the Parties and the public if needed in preparing Final Arguments.

# Submission of Final Arguments

We want to be sure that everyone, even people who could not be at the Public Listening Session because they were working or travelling on the winter road or couldn't get to Colville Lake from their home communities, has a chance to be heard. #### Request for Feedback from the Parties on Non-Party Evidence

The SRRB has taken note of new evidence from a non-Party organisation that is relevant to our central question, "What is the most effective way to regulate the harvest of caribou?" This new evidence is the Łutsël K'é Dene First Nation's <u>public announcement</u> on January 29, 2020 of their *Yúnethé Xá Petthën Hádı – Caribou Stewardship Plan¹*. The <u>January 2020 version of the plan</u> is available online, and the SRRB expects to receive an officially approved version on February 10. The Board invites comments from the Parties regarding whether there is any reason to exclude this recent evidence from the record for the Colville 2020 Public Listening Session.

## Nunavut Wildlife Management Board Bluenose East Hearing

The SRRB is a recognized Party to the Nunavut Wildlife Management Board's (NWMB's) *Public Hearing to Consider the Government of Nunavut's Proposal to Modify the Total Allowable Harvest of Bluenose East Caribou From 340 to 107 and to Establish a Male-Only Harvest Non-Quota Limitation.* The invitation and proposal related to the NWMB's Bluenose East Hearing are on the Colville 2020 Public Registry, as well as the submission provided by the Kugluktuk Angoniatit Association. The Hearing is scheduled to take place in Kugluktuk on March 2-3, with a possible extension to March 4.

The SRRB is preparing a written submission for that Hearing to be submitted by the February 14 deadline, and will present at the Hearing. However, the SRRB's submission will not address any Board decisions, which will not be made public until the Board approval of the Final Report on the Colville 2020 Public Listening Session on March 31, 2020. Additionally, because the record for the
